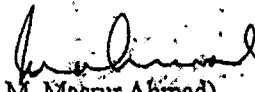

Sub: Allotment of Permanent Private Warehouse Licence Number.

The Commissioner of Customs, Custom House, Chittagong is pleased to accord a permanent licence for a private warehouse under section 13 of The Customs Act, 1969 and BEPZA Act, 1980 in your favour under the following terms and conditions:-

- a) The permanent warehouse licence number 147/2001 is here by allotted against your factory on the basis of recommendation for permanent Bond Registration by EPZ Chittagong vide their letter No. CES- 01-153/1840, Date: 19/05/2004 for importation necessary raw materials to manufacture Jacket, Pant, Ladies Ware, and Knit items for exportation abroad.
- b) You shall abide by and strictly adhere to the relevant sections of the Customs Act, 1969 and the Customs (Export Processing Zone) Rules-1984. In case of any violation or breach of the provisions of the Customs Act, 1969 and the rules and regulations made there under, the Customs authority will have the right to suspend or cancel your licence and simultaneously take other appropriate legal action.
- c) In case of partial or complete transfer of ownership of the company and in the event of any change in the right and title of the company you will have to obtain prior permission at last 1 (one) month ahead to the Customs Authority on submission of authenticated documents.
- d) You shall maintain an account of imported raw materials and stock position in such a manner that can easily be verified by any appropriate officer of Customs.
- e) In addition to that you shall submit the annual stock position in prescribed form as required under the rule-8 of the Export Processing Zone Rules-1984 and standing order number-02/2004 DT. 19/04/2004 of Custom House, Chittagong to the Customs Authority by the following year.
- f) You shall allow access Customs Officers for examination and verification of documents, records, register books of accounts relating to imported raw materials as well as storage etc.
- g) You shall have to observe all the procedure laid down in Sec. 15 of Chapter IV of the import Policy Order and all the rules and regulations provided in the concerned S.R.O's general order and standing order and circular passed by N.B.R. Dhaka and Custom House, Chittagong from time to time.
- h) You shall not liquidate or close the company without informing or giving prior intimation to the Customs Authority.
- i) No wastage of raw materials and packing materials shall be sold or disposed off without prior permission of the Customs Authority.
- j) No document from formerly M/S. B.K. Company Ltd. will be entertained by the Custom Authority from the date of issue of this licence. Further more, the provisional Bond Registration Number will be considered invalid after the issue of permanent Bond Registration Number.
