On the basis of the instruction made by National Board of Revenue in their letter no. 08.01.0000.56.02.002.17(Part-1)/544, Date. 26.11.2024 & letter no. 08.01.0000.56.02.002.17(Part-1)/570, Date. 05.12.2024, The Commissioner of Customs (Bond), Customs Bond Commissionerate, 42 M.M Ali Road, Lalkhan Bazar, Chattogram is pleased to grant a Provisional Bond Licence for a Private Bonded Warehouse in your favour under the following terms & conditions:

- (a) The Provisional Private Bonded Warehouse Licence Number.-**270/2025, Dt: 01/07/2025** is hereby allotted in your favour on the basis of the recommendation made by BEPZA, Karnaphuli Export Processing Zone, North Patenga Chattogram vide their letter No.- 03.06.1565.333.33.214.25-342, Date. 23/04/2025 within the meaning of Bangladesh Export processing Zone Authority (BEPZA) Act, 1980;
- (b) Under this provisional bond licence you (Gold Emperor (BD) Limited.) are entitled only to import capital machineries and construction materials required for your factory in accordance with National Board of Revenue (NBR)'s notifications SRO No.-56 AIN/2017/CUSTOMS, Dated 14/03/2017 and SRO No.-237/AIN/2009/2266/SHULKO, Dated 25/10/2009,;
- (c) You (Gold Emperor (BD) Limited.) shall have to abide by and strictly adhere to the provisions of relevant sections of Customs Act, 2023, related rules, Standing Order No.-05/2014, Date: 11/11/2014 of this office and the Customs (Export Processing Zone) Rules, 1984. In case of any violation or breach of any provision of Customs Act, 2023 and the rules and regulations made there under, Customs Bond Commissionerate, Chattogram shall have the right to suspend or cancel your provisional bond licence and simultaneously take other appropriate legal actions;
- (d) In case of partial or complete transfer of ownership of the company and in the event of any change in the right and title of the company, you must take prior permission at least 01 (one) month ahead from Customs Bond Commissionerate, Chattogram by submitting relevant authenticated documents;
- (e) After installation of machinery and inception of production, you have to submit the certificate from BEPZA Karnaphuli Export Processing Zone Authority and Customs Authority (Customs Bond Commissionerate, Chattogram) along with the fire licence, list of machineries and production capacity, list of raw materials and blue print/layout plan of your premise, factory and warehouse etc. to this office as per law to obtain permanent private bonded warehouse licence;
- (f) You (Gold Emperor (BD) Limited.) must allow access of the Customs Officers to the bonded warehouse for inspection, examination and verification of documents, records, registers, books of accounts relating to imported raw materials, exportable finished goods and stocks etc;
- (g) You (Gold Emperor (BD) Limited.) must also comply with the provisions and observe all the procedures laid down in the Import Policy Order and all the rules and regulations mentioned in the related SROs, general orders, standing orders and circulars issued by the Government of Bangladesh, NBR, Customs Bond Commissionerate, Chattogram and other relevant offices being in force from time to time;

- (h) You (Gold Emperor (BD) Limited.) must construct your factory building including raw materials store and finished goods store, i.e bonded warehouse maintaining adequate safety and security;
- (i) You (Gold Emperor (BD) Limited.) should not liquidate or wind up the company without giving intimation to and having written permission in due course from Customs Bond Commissionerate, Chattogram;
- (j) As per Standing Order No.-05/2014, Date: 11/11/2014 this Provisional Private Bonded Warehouse Licence is valid till 01(One) year from the date of issuance. You have to obtain the Permanent Private Bonded Warehouse Licence within this period; and
- (k) Before obtaining the permanent private bonded warehouse licence you (Gold Emperor (BD) Limited.) have to submit all relevant documents as per ওয়ারহাউস লাইসেন্সিং বিধিমালা, ২০২৪ (SRO No. 209-AIN/2024/61/Customs, Dated: 29/05/2024) & Standing Order No.-05/2014, Date: 11/11/2014.
